- Firms with claim frequency or severity issues
- 4 or more fee suits in the past 2 years
- Practicing attorney(s) or staff whose license has been revoked
- Practicing attorney(s) or staff whose license has been suspended in the past ten (10) years except for past due payment of bar dues or late completion of CLE requirements
- Firms who have or are accepting equity, stock, profits, or gifts from a client in lieu of legal fees
- Firms acting as Lead and or Co-Lead Plaintiff Counsel on Class Actions (other than wage & hour) and/or Mass Torts
- Financial Industry Regulatory Authority (FINRA) against broker/dealers
- Cannabis Law unless limited to criminal defense
- Cryptocurrency Law
